# THE NEXT BOARD OF DIRECTORS MEETING

The next Board of Directors meeting is on Thursday September 12<sup>th</sup> at 7:00pm.

The agenda for all board meetings is posted in advance at the entrance to the Clubhouse. Monthly meetings are open to all homeowners. The 15-20 minute *Open Forum* session at the start is an opportunity to have any issues heard by the board, association manager, and others present, and to ask questions about any projects or decisions addressed by the board.

Following *Open Forum*, the meeting is limited to those issues posted on the agenda. Homeowners are welcome and encouraged to stay and observe, but this part of the meeting is closed to owner participation. Minutes of all meetings are posted on the website after they have been approved at the next board meeting.

#### **AUG/SEP NEWS**

Summer has been a busy time of year with several maintenance and landscaping projects in progress. Recently, some areas of The Vineyards have seen a problem with crows – the advice of the Audubon Society for those affected, is to be vigilant about the disposal of food scraps, and to consider not using bird feeders if they attract unwanted visitors.

#### **FHA CERTIFICATION**

Since the last board meeting we have received news that The Vineyards of Saratoga has received Federal Housing Administration (FHA) Certification. Board President, Jim Foley, has been pursuing this certification for over 2 years. He has spent over 200 hours dealing with Realtors, lenders, 2 federal agencies, the City of Saratoga, West Valley Sanitation District, Santa Clara Valley Water District, the Santa Clara County Recorder's Office, and the Santa Clara County Surveyor. With recent help from Luis Heredia from CMS and Gina Jordan from Commerce Mortgage, certification was finally achieved. We are the only condominium complex in Saratoga to have this status.

FHA loans have been helping people become homeowners since 1934. The FHA, which is part of the US Department of Housing and Urban Development, insures loans so that a mortgage lender can offer buyers better options. The benefits for consumers include lower down payments and closing costs, as well as easier credit qualification than for conventional loans. There are also significant advantages to FHA approval for Vineyards homeowners. More loan options for potential buyers may lead to quicker sales at better prices. FHA approval also gives more options for existing homeowners to refinance to lower monthly payments.

#### **CLUBHOUSE UPDATE**

#### TWO ITEMS FROM THE SARATOGAN

Each quarter the City of Saratoga publishes *The Saratogan* to keep residents apprised of current events and important information. Two items in the current issue have some useful information – a reminder about off-leash dogs within the City of Saratoga, and new information on battery recycling – excerpts re-printed below:

#### Off-leash dogs

Dogs are not allowed off-leash in the City. Dogs must be kept on a leash that is no more than 6 feet in length. The City contracts it's animal control services with San Jose Animal Care and Services. If you see a dog off-leash, contact them at 408.794.7297.

#### Recycle Used Household Alkaline Batteries

Now residents have the option to recycle household batteries curbside through West Valley Collection and Recycling. Residents are asked to place used household alkaline batteries in a clear, sealed plastic bag on top of their recycle carts.
