

# THE NEXT BOARD OF DIRECTORS MEETING

The next Board meeting is scheduled on Thursday Nov 12<sup>th</sup> at 7:00pm.

The agenda for all board meetings is posted in advance at the entrance to the Clubhouse. Monthly meetings are open to all homeowners. The 15-20 minute Open Forum session at the start is an opportunity to have any issues heard by the board, association manager, and others present, and to ask questions about any projects or decisions addressed by the board.

Following Open Forum, the meeting is limited to those issues posted on the agenda. Homeowners are welcome and encouraged to stay and observe, but this part of the meeting is closed to owner participation. Minutes of all meetings are posted on the website after they have been approved at the next board meeting.

#### **OCTOBER NEWS**

The Clubhouse has passed the last required inspection and is open.

The swimming pool heater will be turned off for the season at the end of this month. The spa will remain in operation throughout the cold months.

In anticipation of 'El Nino' bringing heavier than usual seasonal rains, please check the drains under your patio walls, and clear leaves or other debris that could cause your patio to flood. Also, make sure that the level of dirt up the walls in your patio area is below the reglet (the groove in the wall that marks the level for a waterproof membrane / flashing).

Two cars were towed last month, one was left on the perimeter in the 100's by a Highway 85 car pooler, and the second one was parked in the 200's in front of a garage door blocking a fire lane. Although it is not marked with red paint, garage access is part of the fire lane. Unless you are actively loading or unloading, cars left outside must be in a marked parking space. Please note: when we have no contact information, cars that need to be moved for emergency maintenance are towed at their owners' expense. Sooo ... if you have not done so, please fill in and return the Occupancy Form to CMS. New owners / renters please note that this form is available on the Vineyards of Saratoga website. Help us complete this process — make it easier to contact residents in case of an emergency and to identify vehicles that belong to members of our community. If your back window is tinted, put the sticker on the windshield, so the number is clearly visible.

The fall dumpsters are scheduled for October 23<sup>rd</sup> to November 2<sup>nd</sup>. For more information on items you can throw in please see the next page.

#### **FALL DUMPSTERS**

Twice a year the Vineyards provides larger dumpsters for convenient disposal of unwanted oversized items. It's time to gather your bulky giveaway items for the two large dumpsters scheduled October 23<sup>rd</sup> to November 2<sup>nd</sup>. Get rid of rickety old furniture, bed frames, mattresses and blankets, moving boxes, construction wood, curtains and blinds, and such.

These dumpsters are for the use of Vineyards residents only. If you see any outsiders or contractors dumping stuff, please report their vehicle license plates to CMS or better still take a photo.

Do not use the dumpsters to dispose of paints, oils, computers, tires, or any toxic or flammable materials. See below for information from the City of Saratoga website on how to dispose of these items safely.

#### How do I dispose of my old computer, motor oil, paint or toxic materials?

The Santa Clara County Household Hazardous Waste program accepts hazardous materials, including paints, petroleum based products, batteries, drain clog remover, pesticides, gardening chemicals, solvents, pool chemicals, propane, helium, smoke detectors, and medical waste. To make an appointment to drop off these items call 408.299.7300.

West Valley Collection and Recycling, accepts household electronic and universal waste. Examples of household electronic waste include televisions, monitors, keyboards, computers, printers, and DVD players. Household universal waste accepted by West Valley Collection and Recycling includes batteries, flourescent tubes, bulbs, mercury containing lamps, thermostats, electrical switches and relays, mercury gauges, and non-empty aerosol cans. 

#### LANDSCAPING NEWS

Important message from the Landscaping Committee:

Hopefully the rains are coming. Please take time to clean out the drains under your patio walls before the rains in order to avoid flooding. **Tree pruning.** The board accepted a bid from the company Davey Tree to prune our trees this fall. This is an annual maintenance item that had to be skipped last year because of poor growth due to the drought. This year we have been deep watering our most vulnerable trees, and many now need to be pruned back. As well as pruning, some old stumps will be ground out to make way for new planting.



Do you recognize any of the trees above? We have at least one of each in the Vineyards grounds. We have over 150 trees on our property, the tallest of which are the Coastal Redwoods. The many Chinese Elms, Sweet Gums, Eucalyptus, and Live Oaks provide some of the biggest shade canopies. Our ornamental flowering trees include Southern Magnolias, the Tulip Tree, and Crape Myrtles. The Vineyards was built on the site on an old prune orchard; while none of those trees remain, we have many fruit trees including one ornamental Plum Tree, as well as Lemon, Orange, and Crab Apple Trees.
