SAFETY FIRST



'Tis the season of dark mornings and evenings. Our ground level lighting leaves parts of our perimeter road in deep shadow. This is a reminder for walkers, joggers, cyclists and dog walkers to take sensible precautions to be visible after dark and wear light colored or reflective clothing and use a flashlight.

Car drivers please SLOW DOWN !!! The MAXIMUM allowed speed on the perimeter road is 15mph and we need to drive even slower around the blind corners. Speeding drivers on the straight stretches of Vineyard Lane put pedestrians coming out of side paths, walkers around the perimeter, and people walking to their cars at risk.



WINTER SPARE THE AIR IN SAN FRANCISCO BAY AREA

The 2015/2016 Winter Spare the Air season runs from November 1 through February 29. Each day, the Air District issues an air quality forecast for the next day. If air quality is forecast to be unhealthy, a Winter Spare the Air Alert will be called. The alert will be in effect the entire next day, for a full 24 hours. When a Winter Spare the Air Alert is in effect, it is illegal to burn wood, manufactured fire logs, pellets, or any other solid fuels in your fireplace, woodstove, or outdoor fire pit. On average, there are 15 – 20 Winter Spare the Air Alerts each winter.



The nine counties that surround San Francisco Bay are home to almost seven million residents and an estimated 1.4 million fireplaces and woodstoves. Wood smoke continues to be a health concern in the Bay Area and produces about one-third of the particulate pollution on a typical winter night. In February 2015, the U.S. Environmental Protection Agency (EPA) updated its clean air standards for residential wood heaters to make new heaters significantly cleaner and improve air quality in communities where people burn wood for heat. Within a few years, new woodstoves sold in the United States will be required to have a permanent label indicating they are EPA-certified to meet emission limits. A WORD TO THE WISE ON WOOD SMOKE

The main adverse health impact of burning wood, manufactured fireplace logs or similar products in common fireplaces is wood smoke, which contains harmful particulate matter (PM) and volatile organic compounds (VOCs). On its web site, the Bay Area Air Quality Management District states: "During the winter, smoke from residential wood burning is the leading cause of air pollution in the Bay Area. Small particles and toxic chemicals from wood smoke can cause serious health problems, especially in children, older adults, and those with heart or respiratory problems"

Additionally, the California Air Resources Board in its Wood Burning Handbook states: "...Wood smoke also contains VOCs which include toxic and/or cancer-causing substances, such as benzene, formaldehyde and benzo-a-pyrene, a polycyclic aromatic hydrocarbon (PAH). Manufactured fireplace logs, for instance, are not recommended for burning because they produce toxic fumes, including PCBs (polychlorinated biphenyls)..." In order to minimize the levels of indoor combustion pollutants emitted from older types of fireplaces, like the original fireplaces installed at the Vineyards, large volumes of indoor air must be exhausted up the chimney during such burning. As a result, furnaces usually have to run longer in order to heat and replace such exhausted air, thus increasing utility bills.

In summary, one of the best ways to protect you and your neighbors from the adverse effects of toxic air pollutants and possibly save money, is to avoid burning wood, manufactured fireplace logs or similar products in any fireplace at the Vineyards.

BOARD HEARINGS FOR VIOLATION OF RULES

In the past few months we have seen an unprecedented rise in violations of the CCRs, Rules and Regulations. The board has held several hearings; some homeowners were fined and a couple of infractions were dismissed. The list below shows just how bad this situation has become in the last months.

A resident owner was fined \$450 for damage to HOA property as a result of not remedying a leaking water heater for several days A resident owner was fined \$225 for multiple items blocking safe access to the stairwell, landing and under the stairs to their unit An owner landlord was fined \$450 – the tenant was using glass containers and left broken glass scattered on the small pool deck An owner landlord was fined \$500 – the tenant was seen twice with an off leash dog

A resident owner was fined \$250 for accumulated debris on a front patio and not using spacers under plants on a deck

An owner landlord was fined \$150 for repeated improper disposal of large boxes by their tenant

A resident owner was fined \$250 for improper disposal of paint in the recycle dumpster by a contractor

A resident owner was fined \$100 (suspended for 6 months) for improper trash disposal

A resident owner was fined \$200 (suspended for 6 months) for a barking dog left outside the unit
