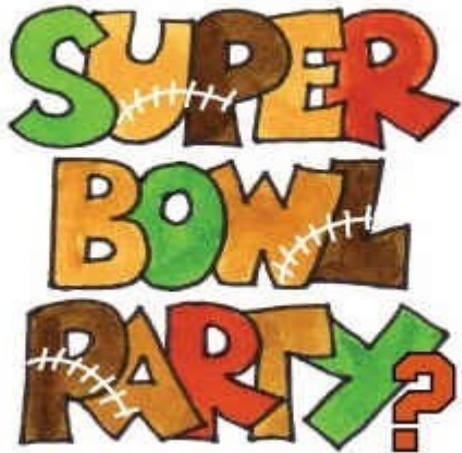
Member Information List
