Garbage & Recycling

Additional garbage costs can be avoided If everyone flattens cardboard boxes before putting them into recycle containers and no one abandons any items on the ground. The garbage collection vehicles will not pick any items from the ground, and if their access is blocked may refuse to take the dumpster out of the enclosure. This is an ongoing problem, especially around dumpster number 3. No items of unwanted furniture or household goods should NEVER be abandoned in or next to the dumpster enclosures. If a dumpster is full, please hold onto your recyclables until the bin has been emptied. Hazardous materials, oil, antifreeze, gas, etc, will not be picked up by the garbage company.

Fine Hearing for Garbage or Recycling Violations

Numerous notices have been posted and sent about the proper disposal of trash and recycling at the Vineyards of Saratoga. Warning letters for violations for improper disposal of either will no longer be sent and a fine hearing will be called.

THE NEXT BOARD OF DIRECTORS MEETING

The Board meeting will be held on Thursday May 12, 2022 at 7:00 PM. Details about attending the meeting will be post in the community at least four days prior to the meeting. You can also email the Association Manager for further details on attending the meeting. The 15-20 minute Open Forum session at the start is an opportunity to have any issues heard by the board, association manager, and others present, and to ask questions about any projects or decisions addressed by the board. Following Open Forum, the meeting is limited to those issues posted on the agenda. Homeowners are welcome and encouraged to stay and observe, but this part of the meeting is closed to owner participation. Minutes of all meetings are posted on the website after they have been approved at the next board meeting.

Please make sure not to leave the following items: pretreated wood, concrete, dirt, tires, engine parts, televisions, mattresses, unbroken furniture, computer monitors, refrigerators / freezers, medical or hazardous waste. These items are not allowed and will cost the HOA, that is anyone who owns property here, extra money.
